Recipe Corner Texas Caviar 2 cans of Mexicorn 2 cups of mayo 8 oz. of sour cream 1 med. onion, finely chopped Jar of green jalapenos, chopped (add as many as you can stand, start with ¹/₄ to 1/3 of a cup) **Brussels Sprouts with Water Chestnuts** 2 pounds of fresh Brussels Sprouts trimmed and halved or 2 14 oz. bags of frozen sprouts 2 tablespoons of butter 2 tablespoons of flour (or corn starch) Salt and pepper to taste 1 cup of chicken or veg. broth 18 oz. can of sliced and drained Water Chestnuts **Cook sprouts and drain.** In small pan, melt butter and add salt, pepper and flour. Maine RV Parking Bill Status

5/12/09

LD114 / HP98, the bill in the Maine State Legislature that would make it a civil offense to park an RV overnight on any public parking lot in the state appears to be a dead duck.

The bill's sponsor, Rep. Anne Perry, D-Calais, asked the House of Representatives today to vote down the bill, stating that it was too broad, could affect too many businesses and impact safety for RV travelers. The house responded by accepting the minority "ought not to pass" report from committee without a roll call. The bill now heads to the Senate with an "ought not to pass" recommendation. Given that the sponsor asked that the bill be killed in the House, it's unlikely that LD 114 will be approved in the Senate.
